Bids received in excess of the total cost per item shall be automatically rejected.

The Local Government of Canlaon City now invites bids for the Supply and delivery of Full Meals and Snacks for the use of LCR, CHO, CMO/CADAC/BADAC, Canlaon City. Delivery of the Goods will be determined by the end-user. Bidders should have completed, within two years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).

Bidding will be conducted through open competitive bidding procedures using a nondiscretionary "*pass/fail*" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.

*B*idding is open to all interested bidders, whether local or foreign, subject to the conditions for eligibility provided in the 2016 revised IRR of RA No. 9184.

Interested bidders may obtain information for the City Government of Canlaon City thru the Office of the Bids and Awards Committee and inspect bidding document during office hours (8:00 AM to 5:00 PM), Monday to Friday.

A complete set of Bidding Documents may be acquired by interested Bidders on *February* 1, 2025, to February 24, 2025 until 10:00 AM at the Office of the Bids and Awards Committee, Canlaon City, and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Five Thousand (P5,000.00) Pesos. Bids must be received by the BAC Secretariat though Manual submission on or before February 24, 2025, 10:00 AM at the Office of the Bids and Awards Committee, 2<sup>nd</sup> Floor, City Hall Building, Canlaon City.

All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 14.

Bid opening shall be on *February 24, 2025, 10:00 AM at the Office of the Bids and Awards Committee 2<sup>nd</sup> Floor, City Hall Building, Canlaon City.* Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.

For the purpose of constituting a quorum, either the physical and virtual presence of the BAC member shall be considered pursuant to GPPB Resolution No. 09-2020.
